Indianapolis, IN – July 5, 2013

Since being established in 2000, the Renaissance Charitable Foundation (RCF) continues robust growth in Donor Advised Funds (DAF). RCF has received more than \$725 million in contributions, and has granted more than \$260 million to charities on behalf of its Grant Advisors.

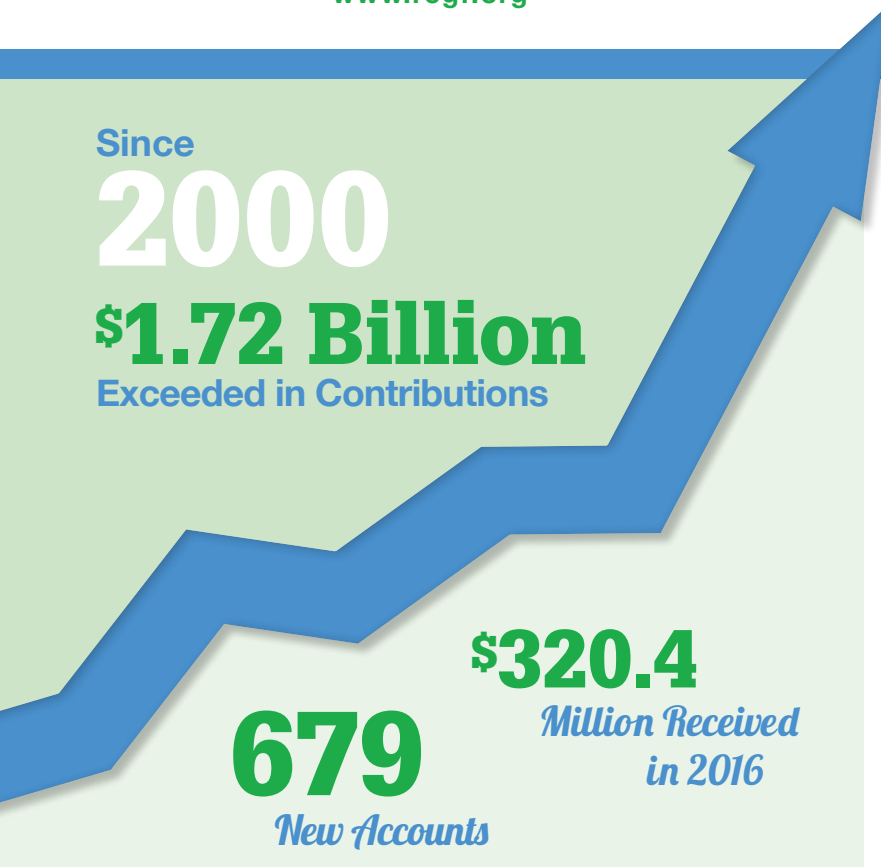

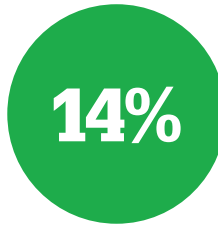

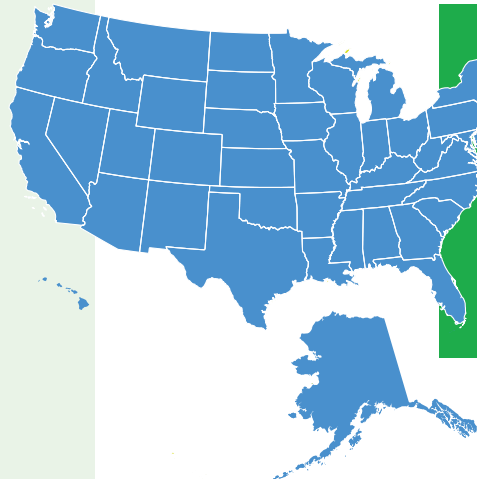
